ORDER

Whereas, the security agencies are desirous that procuring, storing and selling combat clothes - readymade and otherwise may be regulated;

Whereas, the procuring, storing and selling combat clothes in an unregulated manner may result in these items being passed into the hands of antinational elements which may cause disturbance to the public tranquility as has been seen in the recent past;

Whereas, I am satisfied that there is sufficient and urgent reason to regulate the procurement, stitching, sale and storage of combat dress cloth/readymade combat dress to prevent any harm to the public order and safety;

Now in view of the above, I, Sheetal Nanda, IAS, District Magistrate, Samba in exercise of the powers vested in me under section 144 Code of Criminal Procedure issue the following regulations and restrictions to be imposed upon the private parties dealing in procurement/storage and sale, stitching of above mentioned articles:-

- 1 No un-authorized persons/firm shall procure, purchase, store, stitch and sale of Army combat dress/readymade combat dress.
- 2 All authorized private firms/shops procuring, storing and selling combat clothes shall immediately inform in writing to the nearest Police stations regarding their authority to carry on with this business. The time limit for such information will be 15 days from the date of issuance and publication of this order.
- 3 All authorized persons private firms/shops dealing in such articles shall submit fortnightly report of all the sales of combat/Khadi dress/cloth made by them alongwith detailed particulars of the Army/Para Military/Police personals etc to whom the such sales have been made. The said list shall be provided by the dealer/dealers to the concerned SHO's on a fortnightly basis. The register carrying all such details will be maintained properly by each dealer and shall be made available as and when the inspection of the shop is conducted by the competent authorities.

Contd. 2nd.

4. It shall be mandatory for all the authorized firms/shops dealing in such articles to maintain the register giving details of the items received with quantity, date of sale, items sold/quantity of item sold and the address/identity particulars of the parties of individuals to whom sold.
5. All such authorized firms shall sell such articles to bonafide members of Armed forces of the union of India after verifying their identity and recording the names and the units where ever employed etc. on the register mentioned above.
6. An Officer of the Police of the Rank of ASI, and above, shall have the authority to check and inspect such registers on routine as well as for the purposes of investigation and enquiries

This order shall come into force with immediate effect and shall remain in force for a period of **two months** from the date of its issuance, if not withdrawn/rescinded earlier.


