ORDER

**Sub: Sikh Gurdwara Prabandhak Committee Election, 2015 –
Prohibition on sale of Liquor-Regarding.**

Whereas, election to Sikh Gurdwara Prabandhak Committee 2015 shall be held on 08-07-2015 and counting of votes shall be undertaken on the same day;

Whereas, section 135-C of the Representation of the People Act, 1951 provides that no spurious, fermented or intoxicating liquors or other substances of a like nature shall be sold, given or distributed at a Hotel, eating house, tavern; shop or any other place, public or private, within a polling area during the period of forty eight hours ending with the hour fixed for the conclusion of poll;

Whereas, in order to ensure the conduct of peaceful, free and fair Sikh Gurdwara Parbandhak Committee Election 2015, it is imperative to impose ban on sale or distribution of spurious, fermented or intoxicating liquors or other substances of like nature;

Now, therefore, in view of above, I, Sheetal Nanda, District Magistrate Samba in terms of powers conferred upon me under Section 144 of the Criminal Procedure Code 1973, hereby order that no liquor shops, hotels, eating houses, restaurants, clubs, star hotels and any other establishment, individuals etc. within the territorial jurisdiction of District Samba shall serve, give or distribute spurious, fermented or intoxicating liquors or other substance of like nature during the period of forty eight hours ending with the hours fixed for the conclusion of **Sikh Gurdwara Prabandhak Committee**

Election 2015, on 08/07/2015 i.e 06/07/2015(7: 00 PM) to 08/07/2015, till the time counting of votes for the election is concluded at every polling station and the result of the election is declared by the Returning Officer.
